### Conditioning camps

# General information

### Note for kids born in 2006

Because of the high number of registrations in the MAHG program, we are forced to limit the registrations of 4 year olds (born in 2006). Therefore, the registrations will be set aside and kept in order that they are received. On September 1st, if the maximum number of registrations is not reached in MAHG 1, we will start to accept registrations for 4 year olds (born in 2006) until the maximum number of registrations is reached. We will contact the parents whose child has been accepted.

- **Proof of residency:** The registrations that do not include a proof of residence on the territory of the AHMA will be refused. You must provide a proof of residence even if you have provided one in the past.
- **Accepted proof of residency:** Here are some examples of allowed documents. This list is not exhaustive and recent means within the last 3 months.

- **Proof of birth:** A player registering with the AHMA for the first time must submit a proof of birth. A copy of a birth certificate or of the RAMQ card will be adequate proof.
- **Family rebate:** A \$75 rebate will be applied if you register a third child in the same family. For the fourth and following children, there will be no charge.
- **Date of the registration:** In order to pay the "Until June 30<sup>th</sup>" registration fee, the registration must bear a postmark and the cheque must be dated at the latest on June 30<sup>th</sup>, 2010. As well, to pay the "July 1<sup>st</sup> to August 8<sup>th</sup>", the registration must bear a postmark and the cheque must be dated at the latest on August 8<sup>th</sup>. For first-time registrations with the AHMA, you only have to pay the "Until June 30<sup>th</sup>" registration fee.
- **Waiting list:** After July 1<sup>st</sup>, 2010 there is a possibility of a waiting list should the maximum number of players in a category be reached.
- **Returned cheques:** A service charge of \$30 will apply for all returned cheques.
- **Tax receipts:** The tax receipts will be issued for the registration fee amount only, not for team fees. They will be distributed beginning in January 2011.
- **Where to register:** Please bring the registration form to the general assembly meeting. After the general meeting, you must send it by mail to the AHMA.
